A special meeting of the Board of Elections Commissioners of St. Louis County was held at its office located at 725 Northwest Plaza Drive, St. Ann, Missouri, Monday, July 18, 2022.

Chairman Chambers called the meeting to order and a roll call was taken. A quorum was present.

Director Fey then read the following resolution:

**WHEREAS**, Chapter 321 of the Revised Statutes of Missouri prescribes a process for the recall of board members of fire protection districts; and

**WHEREAS**, In accordance with RSMo 321.703, notices of intent to circulate a recall petition to recall Robertson Fire Protection District board members Joan Noel, Becky Reinsmith, and Michael Conley were filed with the St. Louis County Board of Election Commissioners on May 11, 2022; and

**WHEREAS**, On May 16, 2022 the Board of Election Commissioners received a statement from the Robertson Fire Protection District board members in answer to the recall petition proponents; and

**WHEREAS**, On July 11, 2022 the Board of Election Commissioners received petitions for the recall of the above named Robertson Fire Protection District board members; and

**WHEREAS**, The Board of Election Commissioners completed a review of the petitions and the signatures affixed thereto on July 15, 2022; and

**WHEREAS**, After finding each petition to have a sufficient number of valid signatures, the Board of Election Commissioners, on July 15, 2022, submitted to the Robertson Fire Protection District certificates of sufficiency in accordance with RSMo 321.714; and

**NOW, THEREFORE, BE IT RESOLVED BY THE ST. LOUIS COUNTY BOARD OF ELECTION COMMISSIONERS, AS FOLLOWS:**

**Section One:** By the authority granted to the St. Louis County Board of Election Commissioner pursuant to Section 321.714.2 RSMO, the Board hereby orders an election for the recall of Robertson Fire Protection District board members Joan Noel, Becky Reinsmith, and Michael Conley to occur on November 8, 2022.

**Section Two:** For a period of time commencing on July 21, 2022 at 8:00 a.m. and ending on August 19, 2022 at 4:30 p.m., the St. Louis County Board of Election Commissioners shall accept statements of candidacy from those qualified to be elected as successors to any Robertson Fire Protection District board member who may be recalled.


